Public: Information that can be seen and used by everyone inside and outside the Council. 320 - Holly - Fell - Consent not required. 280 - Maple - Crown clean by removal of dead wood. Consent not required. 293 - Ash - Fell to ground level - to preempt failure hazard. 1004 - Maple - Fell to ground level this and adjacent maple (orange paint marked). poor prospect/ low SULE. 1013 - Field Maple - Fell to ground level - poor prospect/low SULE. 1015 - Sycamore Fell to ground level - poor prospect/low SULE.
